ADDITIONAL/OTHER: After review, I respectfully request clarification on why we were given a "satisfactory" rating and not a "very good" or "exceptional" rating based on all the positive feedback our APG team received for this project. Based on FARS definitions for ratings, we believe we are not receiving the rating our work merits. Additionally, the current rating will not be favorable in pursing government work and will cause further hardship as an EDWOSB. Wycliffe has an outstanding track record of receiving very good to mostly exceptional CPARS evaluations.

There were no problems on this project; we performed the work as per the SOW; and the contract was completed on time with no additional cost to the Government. At the final inspection, there were only a couple items that needed to be addressed, two were very minor on the roof that were corrected the next day; and one was to supply and install a ladder which has been completed. It is important to note that we performed additional work by adding platforms at the tops of the ladders for additional safety and easier access getting on and off the ladders on the roof at no additional cost; benefiting the government. Lastly, the Assessing Official Comments stated "...final had an area for cleanup.". This leads us to believe that something was left onsite that needed to be cleaned up. After speaking with our APG team, we don't have any record of any clean up issues and were actually commended for our project. Can someone please clarify this statement or remove from CPARS.

Based on above, I strongly believe we should have at a minimum received a "very good", if not "exceptional" rating.

Would you be so kind as to re-evaluate and let us know your findings. I am open to a discussion at your earliest convenience and appreciate your help in this.
