Assessing Official Comments:

QUALITY: Quality of work provided by Wycliffe was generally very good. Construction size was an issue due to the fact that a WWII era hangar was being renovated. A ceiling drop concern delayed some construction and there were a total of 5 modifications on the project. Quality was never an issue, however.

SCHEDULE: Project was originally scheduled to be completed by 3 July 2014 and was actually completed a year later than anticipated. All contractual performance was good with exception to some elements, such as structural support columns being added, that affected schedule but were not necessarily or always a fault of the contractor (again, renovation of a WWII era building).

COST CONTROL: Modifications for various aspects cost the government approximately \$200K. Cost control did not seem as if it was a priority for the contractor, as they did not know the local area for subcontractors and could have reduced costs at various points.

MANAGEMENT: Performance met contractual requirements, however cure notice and show cause letters were issued to the contractor for failure to meet requirements (or expectations) of timely delivery of the project. The entire project was approximately one year behind upon completion.

SMALL BUSINESS SUBCONTRACTING: Outstanding - Contractor utilized small business whenever and wherever possible.

REGULATORY COMPLIANCE: Contractor met contractual requirements and exceeded many aspects to ensure that building would meet specific LEED initiatives as mandated/requested by the contracting office and National Guard Bureau. Very few, if any, problems were noted for corrective action in this area.

RECOMMENDATION:

Given what I know today about the contractor's ability to perform in accordance with this contract or order's most significant requirements, I would recommend them for similar requirements in the future.
