

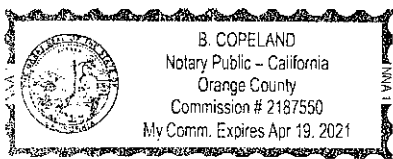

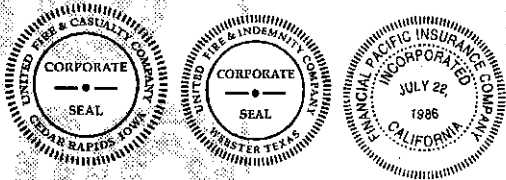
“Article VI – Surety Bonds and Undertakings”
