The failure or default on the part of the Principal in remedying any defects in such work within 30 days after notice shall give the person for whom such work is performed a right of action against the Principal and Surety under this obligation; provided, however, that no suit, action, or proceeding by reason of any default shall be brought on this bond after one (1) year from date of final completion of the work done by the Principal for any such person.

This bond shall be considered continuous until such time as notification of cancellation is furnished to the North Carolina Landscape Contractors' Licensing Board. Cancellation must be received no less than 30 days prior to the cancellation effective date.


