NTDS was the selected company by myself when working for CECOM to do the structured wiring system in Ragatz Hall. This company was selected for a project that consisted of removal of all telephone and data wiring which included twisted pair and fiber optics.

NTDS requirements was to replace all of the existing cable with CAT 5 cable and upgraded fiber optics for upgrading the telephone and data infrastructure to the new 106 new desktop systems that were installed and terminated during the same project that I managed. NTDS had to accomplish running the cables, twisted-pair crossover and termination of all the infrastructure that was installed.

The amazing portion of this project is that this company plus the other two vendors that were contracted that replaced and install new flooring and new furniture implementation had to be completed in 72 hours. NTDS completed this work and tested all the new infrastructure that was installed in the time allowed.

I would definitely recommend them to do this type of work.
