

The Licensee shall timely file all tax returns and pay all taxes due and owing in any jurisdiction in a timely manner.

In accordance with the requirements of Chapter 826-a of the Laws of Westchester County, the Licensee shall notify the Westchester County Solid Waste Commission in a timely manner of any material changes, additions or modifications to the information provided by the Licensee to the Westchester County Solid Waste Commission, whether pursuant to its application for licensure or otherwise.

The Licensee shall at all times cooperate fully with the Westchester County Solid Waste Commission including providing the Commission with requested information in a timely and professional manner.

As a condition of this license, the Licensee shall comply, at its own expense, with all applicable federal, state and local laws, rules, regulations and ordinances which may be applicable to the Licensee in connection with its performance of the activities for which it has been issued a license hereunder, and, in particular those antitrust or other laws relating to the restraint of trade.


